- II. Review of January 2014 Meeting Minutes (Matthews)
 - A. MWR Funding to Return from the State : Response from Commander's Council:

In place of restored MWR funding -

- Commanders Council would prefer to have the state support improved DOT projects that have highest priorities
- Commanders Council would prefer to see funding go towards public instruction improvements, specifically, in the areas specialty education
- Commanders Council would prefer to see funding go to joint 911 call centers as high priority

Motion Made (Matthews): That the committee publicly support in any way feasible the Commission's efforts to promote highway construction needs for all installations, specifically Fort Bragg and MCB Lejeune, with NCDOT and its board and commission. A. Potential 440th Air Wing Transfer - Pope Airfield (Fort Bragg) (Anderson)

Situation:

- 440th Air Wing had a scheduled upgrade for C-130 variant from the USAF
- This upgrade would require USAF logistics that USAF has determined may be best completed by consolidating emergency air wings in Arkansas
- The Army has concerns over the impact on training and readiness for such an air wing being moved and the impact that might have on real time operations for affected units at Fort Bragg

Motion: (Breece - That the committee make a recommendation to the Commission that the Commission executive committee draft a response to counter the potential unit transfer of the 440th. A response similar to the one recently disseminated by the Fayetteville City Council (Attachment A for reference). (Seconded:Matthews). (All in favor).
