Commission Update:

<u>Military-connected Children/Adolescents Behavioral Health-Fort Bragg: Need for Children's</u> <u>Crisis Stabilization Unit</u>

<u>Doug Webster</u>, LCSW – Reasonable treatment has been challenging for military children/adolescents of based upon North Carolina not having a crisis stabilization unit. Purposing a children's crisis stabilization unit within the hospital. The unit would be the first children's crisis stabilization unit in North Carolina, the unit has been very successful in multiple states. The unit runs about 50% less than a hospitalization and just as effective, if not more. Would like to create an awareness of suicidal deaths among military children. Looking for ways to get the initiative funded. Purposing a 6 - 8 bed, the maximum beds are 15, per unit. To build an upstanding unit that provides over 15 beds will cost 2.5 - 3 million dollars. The planning stage will range for 3 months and the total production time will vary for 12 months. The obstacles is funding, roughly a half million dollars. A contract can be negotiated with insurance companies, which will cut the cost to the state.

Need to identify the connection at the state level or federal level, the Governor's office, and legislatures.

<u>George Breece</u> - Draft a letter to engage military affairs commission to support the issue because the money is currently in the Governor's budget.

<u>George Breece</u> - Motion - Quality of life committee endorse the following concepts and ask the North Carolina Military Affairs Commission to use every best effort to get this done now, the language is needed from Doug Webster and others to get provided. The bill has received favorable votes from the Senate and expect to continue with the process and move over the House.
